*The list and isolation requirements shall take effect in accordance with the Cabinet of Ministers on 9 June 2020 Regulation No 360 "Epidemiological security measures to limit the spread of Covid-19 infection" 3. 1 point "The Centre for Disease Prevention and Control, on the basis of information published by the European Centre for Disease Prevention and Control, and for countries where necessary, the information published by the competent public health authorities of the countries concerned publishes on their website list of countries countries to which the special precautionary and restrictive measures apply and the countries where such epidemiological measures have been established situation (including particularly high incidence of Covid-19 or rapid spread of SARS-CoV-2 virus strains threat to public health), which may to create a serious public health risk. The appropriate precautionary and restrictive measures shall be applied on the following day: publication of the referred to list, except in the cases referred to in Chapter V2 of these Regulations regarding the conditions for entry into the Republic of Latvia, which shall take effect in force within two working days of the date of publication"*

# According to sub-paragraph 38.<sup>40</sup> of Cabinet's Regulation until 1st of september of 2021 compliance with requirements shall be confirmed with an interoperable vaccination certificate, test certificate or certificate of recovery issued in the European Union Member States and European Economic Area countries, the Swiss Confederation, or the United Kingdom. When entering from countries that are not European Union Member States and European Economic Area countries, the Swiss Confederation, and the United Kingdom, the fact of testing may be certified with a test result in English or in the language of the exit State. These documents may be in paper form or electronic form (in a smartphone). From 1st of september of 2021 according to sub-paragraph 38.40 of Cabinet's Regulation until 1st of september of 2021 compliance with requirements shall be confirmed with an interoperable vaccination certificate, test certificate or certificate of recovery issued in the United States, the United Kingdom, the Commonwealth of Australia, the State of Israel, New Zealand or Canada. When entering from countries other than the United States, the United Kingdom, the Commonwealth of Australia, the State of Israel, New Zealand or Canada, the fact of testing may be certified with a test result in English or in the language of the exit State. These documents may be in paper form or electronic form (in a smartphone).

+ According to sub-paragraph 38.<sup>39</sup> of Cabinet's Regulation persons must have been tested for COVID-19 within the last 72 hours before boarding the vehicle of a carrier or entering the Republic of Latvia by a vehicle not performing carriage and the test result must be negative. If the person enters from a particularly high-risk country, it is mandatory for such person to undergo the test referred to in this Paragraph, even though such person has been vaccinated against COVID-19 or has recovered from COVID-19 infection.

\$ This designation is without prejudice to positions on status, and is in line with UNSCR 1244 (1999) and the ICJ Opinion on the Kosovo declaration of independence.

& In accordance with Paragraph 38.45 of the Cabinet of Ministers Regulations, a person, except the persons referred to in Paragraph 38.46 of these Regulations, upon entering the Republic of Latvia, shall without delay, but not later than within 24 hours, perform a Covid-19 test, determining SARS-CoV-2 virus RNA at the nearest available test point, informing the laboratory representative of the purpose of performing the test, and in writing or if it has registered for the online test, provide the data referred to in Sub-paragraphs 69.1, 69.2, 69.4.1 and 69.5.1 of this Regulation in writing, shall be recorded in the test certificate for this fact and shall immediately go to the place of self-isolation in accordance with Paragraph 56.4 of these Regulations until the test result has been received.
